

## Information for Authors

Thank you for your willingness to contribute an article. Please adhere to the following guidelines when writing your manuscript:

The right to publish your article in *HTM Journal of Heat Treatment and Materials* is exclusive. Articles that you submit may not have appeared in other publications. Manuscripts should be sent to the editors at the following address:

### Writing and delivering the manuscript

- Articles can be written in German or American English. British English is also accepted. Authors should be consistent in their usage.
- The manuscript must be submitted in both electronic form on some form of data storage media and as a hardcopy printout (German Standard DIN A4 size); submittal via e-mail is also possible.
- Please use the technical terms listed in the European Standard DIN EN 10052 „Begriffe der Wärmebehandlung von Eisenwerkstoffen“ (Vocabulary of heat treatment terms for ferrous products), physical quantities are to be presented in international units as listed in DIN 1304 and DIN 1301 (SI units).

### Text

- The text must be written as a continuous text with no manual returns and no automatic word division, line spacing to be one and a half.
- The text must include a summary in German and English, with the most important prerequisite conditions, objectives and results of the work summarized in **max. 12 lines**.
- The title of the article in German and English should be concise and informative (**max. 50 characters**). A subtitle is permissible. The name(s) of the author(s) with abbreviated first names to be placed above the title.
- A numbered structure (example: 1 Introduction - 2 Schedule of experiments - 3 Experiments - 4 Results - 5 Conclusions - 6 Summary) is required.
- Subheadings are to be identified clearly or numbered. Underlining in the body of the text is to be avoided.
- In mathematical equations that are not created using the formula editor, ensure that characters cannot be misinterpreted (e.g. 0, 0 or 1, 1, I). Equations should be identified by numbers in parentheses in the right margin and be numbered in sequence. Formula symbols and indices used are to be explained in the manuscript. Only the international units of measure listed in DIN 1301 may be used.
- Abbreviations should be generally avoided.
- Use of company names and/or company-owned tradenames in the text is to be avoided as much as possible.

### Figures/illustrations

- Please submit figures/illustrations and tables as separate files (not integrated in MS Office-Applications).

- Grey-scale and color photos must have a resolution of **300 dpi** for a reproduction width of 85 mm; line drawings/diagrams (graphs), a resolution of at least **1000 dpi**.

- The preferred graphic formats are TIFF, JPG (highest quality), EPS and PDF.

**TIFF, JPG (highest quality) and EPS:** With most commonly employed graphics applications (e.g. Photoshop, Illustrator, Origin) you can save your graphics as EPS, JPG or TIFF files; these options can be found in the menu bar under „File“, „Save as ...“ or „Export as ...“. If you use the CorelDraw graphics application, always export the graphics as EPS or TIFF files; do not save in the CorelDraw format! In vector graphics, the font must be embedded in EPS; please use only the following fonts for wording: Arial, Courier, Helvetica, Times or Symbol. The line width should be 0.4 pt to 1.5 pt.

**Acrobat PDF format:** Ensure that your figures/illustrations in PDF format have the necessary resolution: **300 dpi** (reproduction width of 85 mm) for grey-scale and color photos, **1000 dpi** for line drawings/diagrams (graphs). In addition, the fonts used must be embedded in the PDF file. These options can be set when creating your PDF file.

- Articles are generally published in colour reproduction.
- The axes of graphs must be labelled, dimensions to be shown at the upper left and lower right between the numbers (German Standard DIN 461: „Graphische Darstellung in Koordinatensystemen“, Graphic Representation in Coordinate Systems). Use only essential labelling in graphs (remove all unnecessary text). Graphs are published in black and white. Thus please make sure that the differences can be distinguished (e.g. by using different line widths or forms).
- Figures/illustrations are to be numbered consecutively and mentioned in the text. Figure/table captions in German and English should be given at the end of the text (Word document). Figures and figure captions should also be understandable without reference to the text.

### Literature references

- Literature references are to be summarized and numbered consecutively at the end of the article. References in the text are to appear in brackets.
- Only generally accessible sources may be used as literature references; in the case of a "personal communication", the address/company/institute where the individual can be reached must be stated.
- Articles from other periodicals are to be cited using the following sequence:

**Author(s): last name, abbreviated first name**

**Title of the article cited**

**Title of the periodical**

**Volume and year**

**Issue number, page number(s)**

**Example:** Edenhofer, B.; Handel, H.: Use of Atmospheric Furnaces for Carburization at High Temperatures. *HTM Z. Werkst. Wärmebeh. Fertigung* 57 (2002) 5, pp. 357-363

- All authors who contributed to the article must be listed. (Edenhofer et al., for instance, can be used only when cited within the text.)
- When citing books, the author, title, publisher, place of publication and year, together with the referenced page(s) must be list-

ed (in this sequence!).

- In the case of patents, in addition to the country, the patent number and the date filed, the inventor(s) and applicant are to be stated.
- Internet pages are only temporarily available and thus should not be cited.
- We request that the author(s) check the literature reference carefully in the final version of the manuscript.

### Biography of the author(s)

Academic degree, first name, last name, company/institute with company/institute name and location.

### Length

The article should not exceed 6 printed pages in length. This corresponds to about 30 000 characters and 8 figures/illustrations.

### Key words

Please provide at least 5 key words for inclusion in the annual index.

### Review

The manuscript will be submitted to reviewers who recommend whether the contribution should be published or what changes are necessary.

### Corrections

The author receives a galley proof as a PDF file and a publisher form. A printout of this proof with corrections (complying with DIN 16 511) and a signed release granting the right to print the article must be returned to the editors. Please correct only printing errors and avoid making subsequent changes to the composed text. Proofs are relevant only with respect to the composed type, not for the quality of paper or printing.

### Specimen copies and author's preprints

- After the article appears in the journal HTM, the correspondence author automatically receives from the publisher one specimen copy per author.
- In addition, it is possible to have a PDF of the article sent to 10 interested individuals free of charge. In this regard, the correspondence author will receive an e-mail from Carl Hanser Verlag after the issue containing the article has appeared.
- Author's run-on prints (max. 250 copies) must be ordered prior to receipt of the notification that the article is ready to print. An order form is sent together with the galley proof. Author's run-on prints are included in the production run of the journal; they thus contain non-related text that is printed on the same page.

### Reprints

Upon request, reprints can be printed or can be written in electronic form as a high-resolution or low-resolution PDF file (300 dpi or 72 dpi). Because of the relatively high cost to produce the printing plates for hardcopies a minimum print run of 500 copies is necessary. A form that can be used to request a separate proposal for reprints accompanies the galley proof.
